Hero artwork for the Wagga Wagga City Council Reconciliation Action Plan document renewal.

#### **PROJECT BRIEF**

Wagga Wagga City Council is updating our Reconciliation Action Plan (RAP). A RAP is a strategic document that will support Council's business planning and will include practical actions to ensure better outcomes for Aboriginal and Torres Strait Islander people.

The project will have branding applied to it to ensure professionalism and consistency in how it is represented and promoted to the public. This visual branding will be led by the use of the commissioned artwork to create the look of the plan. It is the artwork element that this EoI addresses.

Council will commission the production of an artwork from a local Wiradjuri/Wiradyuri Artist to will be used as part of the branding for the updated Reconciliation Action Plan. The artwork will be predominantly used for (but not limited to) the Reconciliation Action Plan and its promotion, on



Council's Acknowledgement in the Civic Centre and other cultural facilities where the Acknowledgement is present, social media posts, and website.

Application of the artwork will involve using different details (zooming in on sections) to allow for versatility and variety, this means that the artwork may not be displayed in its entirety.

#### **ELIGIBILITY**

You must be a local Wiradjuri/Wiradyuri artists/arts collectives eligible to work in Australia. A current ABN and NSW Working with Children Check is recommended but is not mandatory to apply. Artists/arts collectives must have no outstanding grant acquittals or outstanding debts owing to Council.

For younger artists who may not have any prior experience but are interested in applying, we encourage that you reach out to Wagga Wagga City Council's Aboriginal Community Development Officer – Michaella Alexander – in order to be connected with a local Elder or mentor to support your submission.

#### **PAYMENT + COPYRIGHT**

As payment for licensing Council to use and reproduce the artwork, the successful artist will receive a total, one off payment of **\$2,500** (exclusive of GST) from Wagga Wagga City Council in line with National Association for the Visual Arts (NAVA) rates. Council is not purchasing exclusive rights to the artwork and is not acquiring the physical realisation of the work. The artist will be required to sign a Copyright Licensing Agreement.

#### PREFERRED THEMES AND STYLE

The project's purpose is to recognise Wiradjuri/Wiradyuri and First Nations community members. We're interested to hear creative ideas around the themes of:

- Coming Together
- Reconciliation
- Wagga Wagga place of many celebrations

We would like the design to reflect local Wiradjuri/Wiradyuri artistic practices. The artwork should be created using traditional mediums (drawing, painting, mixed media), and then scanned or photographed into a digital file for use in subsequent graphic design.

It is preferred that the subject is abstract and symbolic rather than naturalistic or representative (i.e. landscape, object, people). The artwork can be either colourful or monochromatic.

#### **MATERIALS TO BE PROVIDED**

On completion of the design of the artwork, we will require a high-resolution digital image of the graphic in jpeg/tiff or similar appropriate file format.

#### **CONSULTATION PERIOD**

Prior to commencing work on the artwork there will be time allocated for the successful artist to engage in consultation with relevant Council officers and Wiradjuri/Wiradyuri and First Nations Elders and community members. This time is to collaborate and develop ideas to provide adequate information and groundwork for the artist to work from. This will involve outlining the branding process, researching examples of other Wiradjuri art used in branding, discussing the project and conceptualising ideas and process.



### **SELECTION PROCESS**

Following the close of the Expression of Interest period, the Selection Panel will select the artist/s to be commissioned.
