- ❖ Sound system with operator;
- ❖ 3 x microphones with 5 (five) metre leads;
- ❖ 3 x microphone stands; and
- ❖ 1 x DI input for keyboard.
- ❖ 2 guitar leads

Performers must provide the festival organiser with a copy of the backing track (music) to accompany their performance on MP3 file format only. No other format will be accepted.

2. Wagga Wagga City Council reserves the right to reject any application that does not fit within the scope of this family-friendly community event.
3. Young people under the age of 16-years must be supervised at all times by a parent and/or caregiver.
