Permit to Clear Vegetation (Trees)

State Environmental Planning Policy (Biodiversity and Conservation) 2021 – Part 2.2 Vegetation in Non-RuralAreas 2021 (SEPP)

Please read this information carefully before filling out the Permit to Clear Vegetation (Trees) form.

- This form relates to trees on private property only. For Street (Public) Trees please <u>Submit a Street</u> Tree request.
- The permit form is to be signed by the property owner(s).
- A non-refundable permit fee applies.
- If the tree is located on a common boundary, all parties that have joint ownership of the tree are to sign the permit form.
- If the permit is in relation to any proposed or current development, building or subdivision application, you are still required to complete and lodge this permit form and pay the permit fee.
- A request to prune or remove a tree to eliminate the shedding of leaves or to enhance a view will not be considered – removing trees is generally not considered unless they are diseased, dying or dangerous.
- In some situations, Council may request an additional report by a suitable qualified arborist or structural engineer at the applicant's expense to support the permit.

Once lodged, your application will be given a Customer Reference Number.

Note: Your application will be assessed within twenty-eight (28) working days.

A Permit is Not Required for the Following:

Dead trees: these can be removed without approval (this only applies to lots less than 0.2ha in size).

Street trees: for requests for street tree pruning or removal, fallen branches, vandalism etc.

If the tree in question is a street tree, or located in a park or reserve, a request for assessment of the tree can be made online at Council (see links below), or by telephoning Customer Service on 1300 292 442.

Undesirable plants as listed in section 5.2.3 of the <u>DCP 2010.</u>

Trees of a height less than 8m, unless it is a Species of Local Conservation Significance as identified in Table 5.2.2 in Section 5.2 of the <u>DCP 2010</u>.

Overhead power lines: for trees impacting on electrical service wires within your property, contact Essential Energy on 13 20 80.

Neighbouring trees: Council does not get involved in neighbour disputes. In such situations, the parties involved should contact the <u>Community Justice Centre</u>. Refer to <u>DCP 2010</u>, Section 5.2 for exempt pruning.
