Disclosure Log

A disclosure log is a record containing details of information released under the Government Information (Public Access) Act 2009 (GIPA Act) following an access application, if the agency releasing the information considers it may be of interest to other members of the public. For this reason, information relating to some but not all access applications is listed. We consider each application for inclusion and usually conclude that it would not be of interest to anyone except to the applicant. Similarly, we have decided to list applications for five years only, on the basis that information that may have been of more general interest is very unlikely to retain that interest beyond five years. Details are entered into the disclosure log after the access application has been decided, and when review rights relating to the agency's decision to include the details of the released information in the disclosure log are no longer pending.
